This is regarding revised Procedure for release of Bank Guarantees. To stream line the process of release of BG, the following procedure is approved by CGCA.

- 1. The procedure shall be applicable from 1st April 2022 onwards.
- 2. No Dues Certificate (NDC) by AS/CS/DS Wing shall be provided along with the issuance of letter of termination/surrender/expiry of licenses. This will reduce procedural delays.
- 3. Each case of any instance of release of Bank Guarantees will be numbered and tracked by Revenue Section.(XX YY ABCD) (XX-License type, YY-CCA, ABCD-running Number)
- 4. Within 3 working days of receipt, issuance of letter of termination/surrender/expiry along with no dues by the concerned wing will be forwarded by Asstt. CGCA (Revenue) to DGT/LSA, WPC/WPF and CCAs/LFA.(As applicable)
- 5. DGT/LSA, WPC/WPF and CCAs/LFA shall have one week time to give their respective NDCs.
- 6. All NDCs shall be sought and received on email(without paper work)
- 7. Revenue Section after receiving all required NDCs from respective sections shall put up the file for approval for release of BG. This shall take one week's time. Subsequently O/o CGCA will issue orders for release of BG to concerned CCAs.

The whole process from the initiation of BG Release to the actual release of BGs is proposed within 1 month.
