Subject: Streamlining the process for reporting violation cases of ISP licensee's for termination by CCA offices.

DS wing of DoT is receiving the cases against the ISPs licensees for termination from various CCAs after encashment of FBG/PBG of the ISP licensee in view of the followings:

- i. Non-renewal of FBG/PBG in due course.
- ii. Non-replenishment of FBG/PBG amount after its encashment.
- iii. Non-submission of License fee and related documents/statements.
- However, many of these cases are received without enclosing communication/notice to the ISP licensee seeking explanation and subsequent examination for reply from ISP licensee, recommendations in the violation case with violated conditions/clauses and legally sustainable reasons along with draft show cause notice prepared with violated clauses and clear mention of established violation.
- The above mentioned information/documents are required before processing such case, so that department can have a legally tenable/sustainable violation case before initiating any action against the licensee and to withstand the judicial scrutiny that may take subsequently in future. Further, non-availability of such documents results into avoidable correspondence and delay thereof.
- Therefore, in order to streamline the processing the cases related to termination of license as per terms and conditions of license and avoid delays, all the CCA units are again requested to provide following document/information along with any recommendation for cancellation of License due to breach of financial condition(s) of License:
 - 1. Present status of PBG/FBG of the licensec.
 - ii. Confirmation regarding calculation of License fee/AGR are in accordance with all legally tenable provision for calculation of AGR/License fee for the internet service providers in view of all litigation/Judgement made till date, so that any litigation may be avoided in future.
 - III. Evidences like communication/notice to the ISP licensee seeking explanation and subsequent examination for reply from ISP licensee so that department can have a legally tenable/sustainable violation case before initiating any action against the licensee and to withstand the judicial scrutiny that may happen subsequently in future.
 - iv. Recommendations in the case with violated conditions/clauses and reasons for established violation.
