## (b) SYLLABUS OF THE EXAMINATION:

#### (c) ELIGIBILITY:

Lower Division Clerks who have successfully completed their period of probation and have completed 3 Years of regular service (Including Probation Period) as on 01st September 2024 are eligible to appear in the LDCE 2024 for promotion from LDC to Junior Accountant.

#### (d) AGE:

Officials should be above 18 and less than 60 years old as on 01<sup>st</sup> September 2024.

#### (e) MODE OF SELECTION:

Limited Departmental Competitive Examination.

Minimum qualifying marks shall be as follows:

In case a candidate fails to obtain minimum marks in any of the papers, he/she shall not be considered for the final merit list. The circle-wise final merit list of the candidates will be prepared on the basis of aggregate marks obtained in all three papers.

As per the circle-wise merit list, the Appointing Authority of each circle will issue the promotion orders of the successful candidates limited to the vacant post(s) of Junior Accountant in the Departmental Examination quota as per available vacancies in the reservation roster after obtaining vigilance clearance. In case two candidates attain the same marks, the candidate who is older will be allotted higher rank.
